Deadline: August 30, 2018

INSURANCE WAIVER

THIS WAIVER AND RELEASE is made by _____ (“Exhibitor”) in favor of the Federation of Analytical Chemistry and Spectroscopy Societies (FACSS) and SciX 2018

INTENT
